Dear Mr. Alvarez: The purpose of this letter is to express my intent as the author of Senate Bill 54, known as the California Values Act. The intent of Senate Bill 54 is to prevent state and local law enforcement agencies from acting as agents of Immigration and Customs Enforcement. In furtherance of the intent of Senate Bill 54, there is a provision in the legislation that places limitations on a law enforcement agency's ability to contract with the federal government. Specifically, California law enforcement agencies cannot:

Contract with the federal government for use of California law enforcement agency facilities to house individuals as federal detainees, except pursuant to Chapter 17.8 (commencing with Section 7310).

The intent of this provision is not to create a blanket prohibition on a law enforcement agency's ability to contract with the federal government. Rather, the intent of this provision is to limit the ability of a law enforcement agency to contract with the federal government for use of the law enforcement agency facilities to house individuals as federal detainees for civil immigration purposes. The only exception to this is already provided for by law, pursuant to Chapter 17.8 (commencing with Section 7310).

For the benefit of interested parties, I hereby commit to further clarify the intent of this provision at the earliest opportunity.

Dear Mr. Secretary: I request that the following letter stating my legislative intent regarding SB 5 be printed in the Senate Daily Journal:

1. **FLOOD PROTECTION:** The Department of Water Resources, when implementing Public Resources Code Section 80145(a)(1)(C), direct public funds to projects with the primary objective of reducing flood risk to areas protected by levees and facilities of the State Plan of Flood Control.

This provision provides public funds to incentivize the construction of multi-benefit flood risk reduction projects where feasible—as described in and defined by the 2017 Update to the 2012 Central Valley Flood Protection Plan—in order to maximize the effectiveness of limited State funds and to address legacy impacts on fish and wildlife resources.

The department should take into consideration unavoidable physical project constraints that may minimize opportunities for fish and wildlife enhancements. It is the intent of the Legislature that when such constraints are identified, the department will work collaboratively with project proponents to promote fish and wildlife enhancement opportunities, where feasible, while retaining the project’s primary objective of reduced risk to life and property. It is also the intent of the Legislature that the department interpret “measurable Fish and Wildlife enhancement” to mean the measurable improvement of ecosystem conditions for either fish or other wildlife, or both.

2. **SETTLEMENTS AND DELTA CONVEYANCE:** Funds allocated pursuant to Section 80114(a) are not meant to advance Delta conveyance facilities and cannot be used for mitigation of such facilities. My expectation and intent is that the Natural Resources Agency and Department of Fish and Wildlife will seek input from the Delta Conservancy as they expend funds to implement any voluntary agreement that satisfies subdivision (b) in Section 80114. This expectation and intent are limited to those restoration activities that would occur within the legal Delta.

3. Section 80022(a) states that, to the extent feasible, state agencies receiving funding under this division seek to achieve wildlife conservation objectives through projects on public lands or voluntary projects on private lands. The language in this section regarding durability of investments should not preclude habitat restoration on private lands, including the provision of temporary or seasonal habitat that provides critical benefit to wildlife. Approximately half of the acreage in the State of California is privately owned. If the state is going to achieve its wildlife conservation and environmental protection, we must work with willing landowners to implement projects on private lands. This will be especially important as



the impacts of climate change, including rising temperatures, altered habitat conditions, and changing patterns of precipitation, force many species to move in search of better conditions.

4. **HABITAT RESTORATION:** Throughout SB 5, there is language highlighting the importance of improving climate adaptation and resiliency (80076(d), 80130, 80132(a)(3), 80133(a), 80134(a)). It is the intent of the Legislature to recognize that conservation investments must be guided by the need to adapt to the shifting temporal and geographic needs of wildlife and for the Wildlife Conservation Board, Department of Fish and Wildlife, and other state agencies tasked with the implementation of SB 5 to solicit and fund projects that reflect the flexible management or protection of natural resources in response to changing conditions and threats to habitat and wildlife. These types of projects can contribute to the long-term health and resiliency of ecosystems and wildlife populations, especially amid rapidly shifting habitat conditions.

5. **FISH AND WILDLIFE PROTECTION:** Section 80132(g) dedicates funding to improve conditions for fish and wildlife in streams, rivers, wildlife refuges, wetland habitat areas, and estuaries. It is the intent of the Legislature that an important priority for expenditure of these funds shall be to provide funding for long-term conservation efforts that “dynamically” provide water for fish and wildlife. The ability to apply voluntary water and habitat transactions will allow conservation programs to be responsive to changing conditions, and to ensure that resources are focused on precisely where and when water is needed most.
