Re: Motion to Print in the Journal the Following Letter of Legislative Intent as to SB 1421 (Skinner), Chapter 988, Statutes of 2018

Dear Ms. Contreras: As author of SB 1421, I wish to clarify the intent of SB 1421 and the disclosure of existing documents in possession of public agencies.

The plain language of SB 1421, Chapter 988, Statutes of 2018 and the California Public Records Act within which it operates, make clear, that any and all records that fit within the categories defined that are in the possession of the agency are subject to disclosure when an applicable request for a public record is received regardless of when those documents were created or when the underlying conduct occurred. The Senate Public Safety analysis noted arguments to this effect. Therefore, it is my understanding in enacting SB 1421 that the change in the law applies to all disclosable records whether or not they existed prior to the date the statute went into effect. This is the standard practice for public records legislation in California.
